30) To do any other act for advancement of general public utility not involving the carrying of any activities of profit.

31) All other social activities which are required for attainment of aims and objects of the trust which will be decided by board members with the permission of President.

32) To help the needy and deserving people without any discrimination of religion, cast, creed etc.

33) To support the economically weaker people in the areas of education, health and skill initiatives enabling them to support themselves.

34) To help the physically & mentally challenged people to lead respectable lives by rendering love, care and support.

35) To build support for humanitarian efforts for relief and care and also approach Govt for giving information of any injustice to any person as per constitution of India.

6-THE PROPERTIES OF THE TRUST

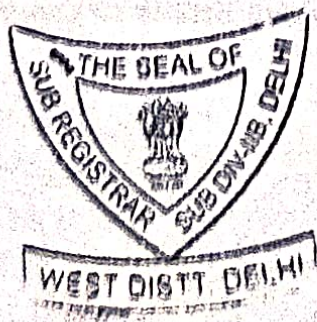
The properties of the Trust shall be:-

10-ADMINISTRATION OF THE TRUST:-

-The administration of the TRUST shall vest with the Board of Trustees which shall consist of :-

- a. One Settler /President.
- b. One Gen. Secretary
- c. One Cashier
- d. One Trustee.

11-POWER AND FUNCTIONS OF THE BOARD OF TRUSTEES;

The Board of Trustees shall have the control and management of the Trust and exercise the following powers as the President is sole responsible and controller of trust:

- i) To institute, file, conduct, defend, compound, withdraw, compromise, adjust appeal, refer to Arbitration or to do such other things as are incidental and necessary, concerning the legal affairs of the Trust and to sign and verify Vakalatnamas, appoint counsels/advocates, pleaders, issue instructions to draft, signs, verify pleadings, affidavits, plaints, complaints, replies, rejoinders etc. and other such similar powers for execution of any such legal document and legal formality with a view to protect the interests of the Trusts as deemed fit from time to time;
- j) To delegate all or any of the powers vested in the Trustees to a competent person for framing of the Rules, Bye-laws and other Codes of conduct for the management, control, supervision, administration of the affairs of the Trust and its transactions and for establishing any Committee;

22-IRREVOCABILITY:

We undertake that the trust/ company is irrevocable in nature and in case of winding up or dissolution of the trust, property of the trust/society/company shall be given or transferred to such other company/society/trust having objects similar to the objects of the trust/society/company. We further undertake that the trust/company will insert the relevant clause in desired format in Trust Deed, if required.

23-DISSOLUTION :
